Spring is in the air and that means dogs like to wander.

Please be mindful that Garfield does have a leash law. In addition to the leash law, *PLEASE* remember that the City Park is for kids and families to enjoy and not a doggy restroom.



But WHY is the leash law important?

- •A leashed dog is less likely to get hurt from cars, wildlife, or other dangers.
- •A leashed dog is less likely to get into a fight with another dog. <u>Just because your dog is friendly doesn't mean the other dogs he encounters will be.</u>
- A leashed dog won't be a pest to others.
 Not all people are comfortable around dogs, even if they're friendly.
- •A dog on a leash lessens the chance of a bite. If your dog gets scared or upset and bites a person or someone else's pet, you could be facing some serious consequences.

The Open Book Meeting for the City of Garfield in Douglas County, Minnesota, will meet on Friday, April 10, 2020, at 9:00 AM at the Courthouse - Board Room by appointment only, for the assessment year 2020 (taxes payable 2021). The purpose of this meeting is to determine whether property in the jurisdiction has been properly valued and classified by the assessor.

If you believe the value or classification of your property is incorrect, please contact your Assessor's office at (320) 762-3884 to discuss your concerns. If you disagree with the valuation or classification after discussing it with your assessor, you may appear at the Open Book Meeting to appeal. The Open Book Meeting staff will review your assessment and may make corrections as needed. You must appeal to the Open Book Meeting before appealing to the county board of appeal and equalization. All appeals are by appointment.
